### Summary Explanation/Background:

The consulting/professional services between the City and Tetra Tech, Inc., was approved by City Ordinance No. 2016-26. This is done every five years. This Work Authorization will allow Tetra Tech to update the Reuse Water Master Plan. The master plan will evaluate the existing system, estimate demand projections using current growth assumptions, update the existing hydraulic model to assist in identifying system sizing deficiencies and develop a capital improvement program to accommodate future demands.
