### Summary Explanation/Background:

Please place the attached resolution on the September 11, City Commission Agenda. The license agreement is for the Pompano Chiefs Football Team, Inc. to operate the city's concession stand at Mitchell/Moore Park to raise funds to benefit the Pompano Beach Chiefs Football and Cheer Program. The scope of the agreement is outlined in Exhibit A of the license agreement.
