## Summary Explanation/Background:

Staff is seeking approval of an Interlocal Agreement (ILA) with Broward County. The agreement will allow the City of Pompano Beach to piggyback on an existing Broward County contract # C1347414B1 and retain DP Development of the Treasure Coast, LLC., a Broward County approved contractor, to provide traffic signal installation services. In addition, the agreement includes provisions for the City of Pompano Beach to be reimbursed for design and construction administration services and construction costs to install a new traffic signal at the intersection of NW 27th Avenue and DR. Martin Luther King, Jr. Boulevard. The total reimbursement amount is anticipated to be \$603,570.00. Staff intends to present a separate agenda item for City Commission approval piggybacking the aforementioned contract and awarding it to DP Development of the Treasure Coast, LLC.
