#### Summary Explanation/Background:

As part of Turnpike Project (FPID 429339-1-52-01) to eliminate manned booths, new signs will be required to be installed along Dr. Martin Luther King Junior Boulevard indicating to customers they will be billed through Sunpass or "tolling by plate". One of these signs is proposed to be installed within City right-of-way. As such, Florida Department of Transportation (FDOT) reached out to City to request securing the proposed maintenance and construction easement attached. Test holes were completed at proposed sign location and all is clear of utilities.
