**Summary Explanation/Background:**

The Development Services Department has prepared a text amendment to Chapter 155, which clarifies that when a use is defined as a “Sexually Oriented Business” that shall be considered the principal use and multiple principal uses would not be permitted. Additionally, the proposed amendment limits the number of permitted accessory uses connected with Sexually Oriented Businesses. The Planning & Zoning Board unanimously recommended approval of the proposed text amendment at the April Meeting. A memorandum has been added to this back-up, since first reading, that references the various studies that can be downloaded from the hyperlink included with the back-up.
