Summary Explanation/Background:

Raftelis Financial Consultants, Inc. (RFC) has been providing rate and financial consulting services to the City of Pompano Beach Utilities Department since 2005. This professional consulting service agreement will allow Raftelis to develop rates that will provide sufficient and stable revenues. They prepare annual rate report updates and calculate wholesale rates for Lauderdale by the Sea and Broward County.
