Summary Explanation/Background:

As a component of the GO Bond Ocean Boulevard (A1A) streetscape improvement project, City will be converting the overhead electric to underground along A1A in two (2) phases; Phase 1 is from Terra Mar to Atlantic Blvd and Phase 2 is from Atlantic Blvd to the Hillsboro Inlet. Florida Power and Light (FPL) will be supplying the material and City's contractor will be completing the conversion under a future, separate contract.

In order to facilitate this, FPL requires that we enter into the attached three (3) Agreements with them for both phases. The three (3) Agreements are as follows:
