Summary Explanation/Background:

Staff is seeking City Commission approval of an Ordinance to execute a contract with Marlin Engineering (ME) in the sum of \$699,762.10. The firm was selected to assist the City with design services to improve Riverside Drive from Atlantic Boulevard to NE 14th Street (see Location Map). ME will work on roadway realignment to resolve encroachments onto the travel lanes from adjacent private driveways; design of drainage facilities to help reduce ponding conditions caused by severe storms and add facilities to offset impacts from future sea level rise; evaluate and assist with installation of FPL lighting equipment throughout the corridor to provide adequate coverage within the public right of way; identify opportunities to add sidewalks, particularly along the east side of the road; increase landscape and add irrigation equipment as needed, to name a few (see Exhibit A - Scope of Services). The roadway was previously evaluated by the Renaissance Group during the corridor studies conducted in 2013. Improvements to this corridor were prioritized and the City submitted a request to Broward County for consideration to fund the project with Penny for Transportation (Surtax) funds. The project was subsequently approved and certified via an Interlocal Agreement (ILA - see attached), which was executed by the City on March 22, 2022, and the County on March 29, 2022. The funds were earmarked in Surtax Cycle I. Note that construction funds are earmarked in the Surtax plan for FY 26. Therefore, construction is not expected to start before 2025, or later. Staff has asked the County to consider making funds available sooner, if possible, but availability is dependent on a number of variables, such as higher-than-anticipated Surtax revenues, other priorities, etc. Nonetheless, staff recommends approval of this Ordinance.
